I AM VOLUNTARILY PARTICIPATING IN THIS ACTIVITY WITH KNOWLEDGE OF THE DANGERS INVOLVED AND HEREBY AGREE TO ASSUME ANY AND ALL RISKS, INCLUDING THOSE OF PHYSICAL, MENTAL OR EMOTIONAL INJURY, PROPERTY DAMAGE, OR DEATH, AND VERIFY THIS STATEMENT BY PLACING MY INITIALS HERE:_____.
